

Fig. 1 - Typical Output Characteristics




Fig. 2 - Transfer Characteristics




Fig. 3 -  $R_{DS(ON)}$  --  $V_{GS}$




Fig. 4 -  $R_{DS(ON)}$  —  $I_D$




Fig. 5 - Capacitance Characteristics





Fig. 6 - GateCharge

Fig. 7 - Normalized Threshold Voltage




Fig.8-Normalized On Resistance Characteristics




Fig. 9 -  $I_S$ — $V_{SD}$




Fig. 10 - Drain Current





Fig. 11 -  $P_D$  Dissipation

Fig.12 - Safe Operation Area





Fig.13 - Normalized Transient Thermal Impedance
