Suggested Solder Pad Layout




Fig. 1 - 8 X 20µs Pulse Waveform Peak value I_{RSM} @ 8µs Percent of Peak Pulse Current (%) Pulse width(tp) is defined 80 as that point where the peak 70 current decay=8µs 60 Half value $I_{RSM} @ 20 \mu s$ 50 40 30 20 10 0 0 20 40 60 80 Time (µs)
