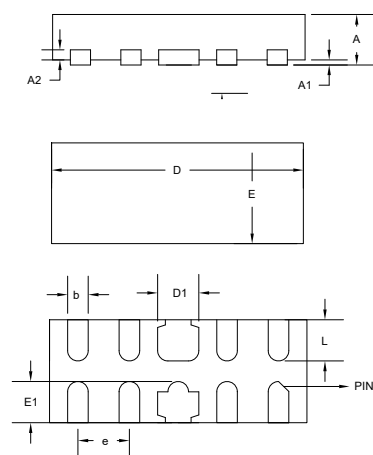

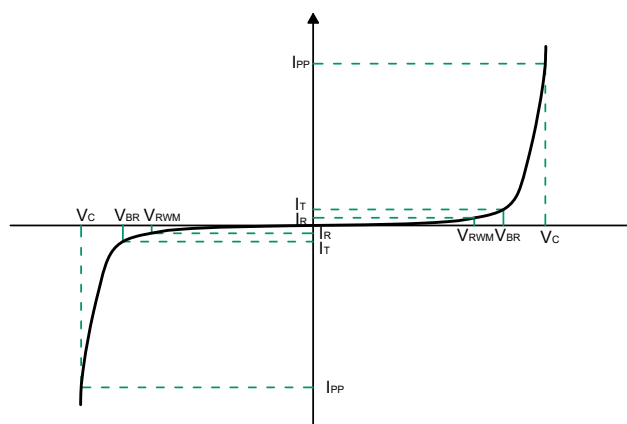

Fig. 1 - 8 X 20 μ s Pulse Waveform

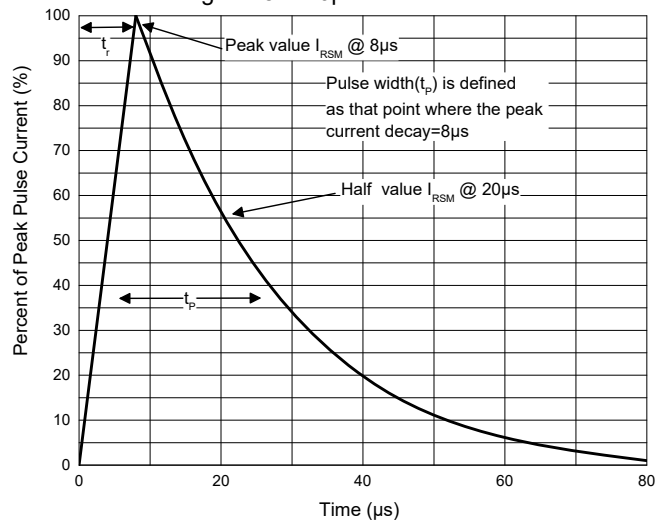


Fig. 2 - Non-Repetitive Peak Pulse Power

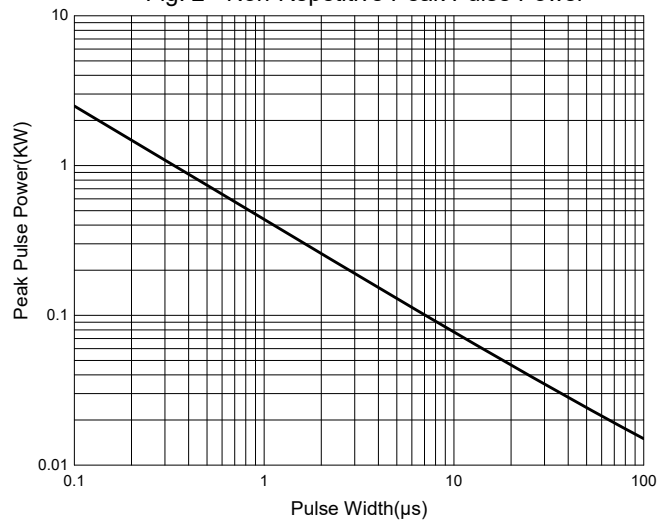


Fig. 3 - Capacitance Characteristics

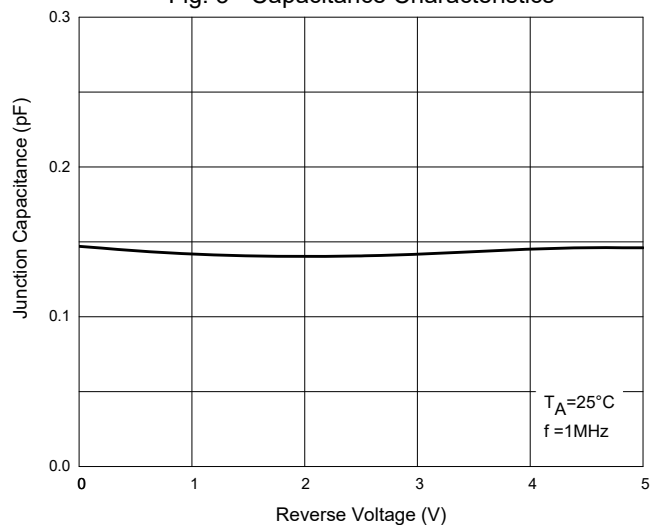


Fig. 4 - Clamping Voltage Characteristics

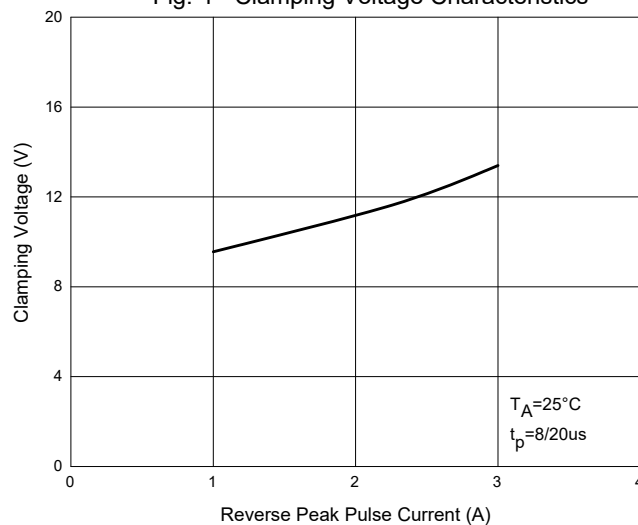


Fig. 5 - TLP Curve

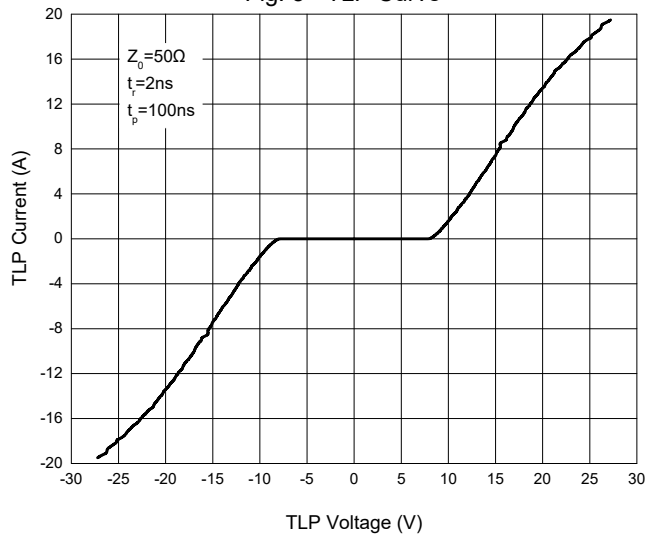
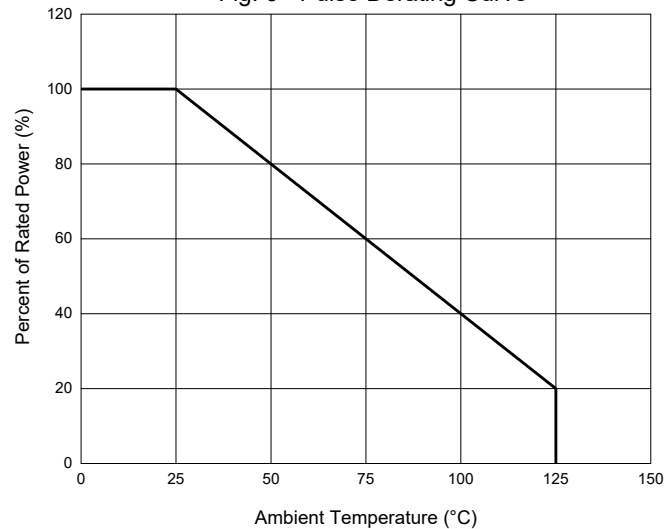


Fig. 6 - Pulse Derating Curve

Fig. 7 - Insertion Loss VS.Frequency

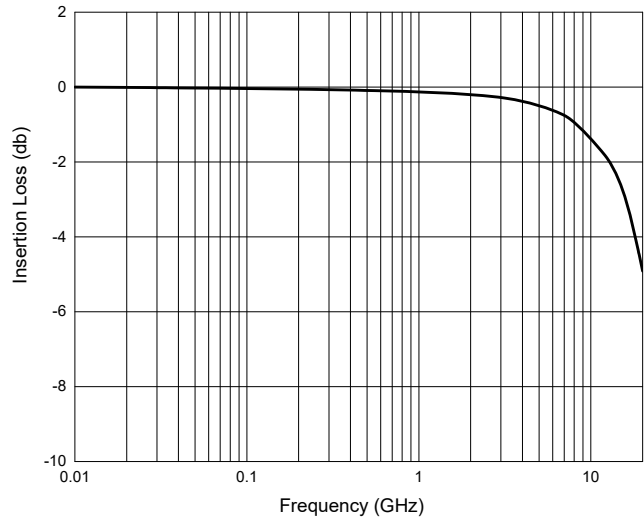
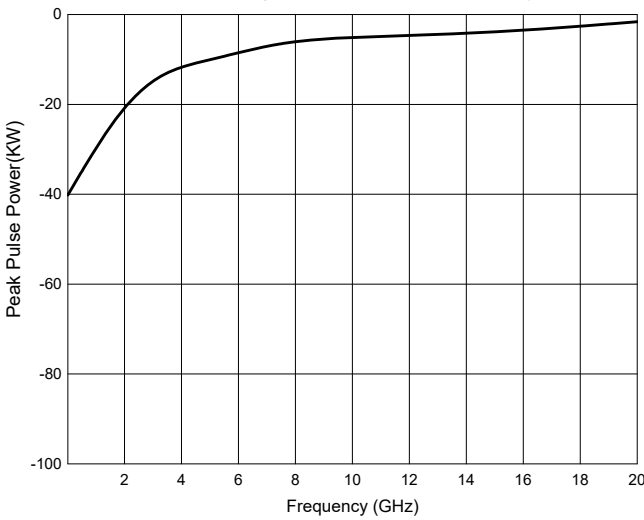


Fig. 8 - Return Loss VS.Frequency
