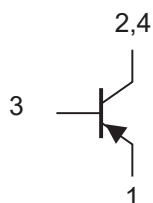

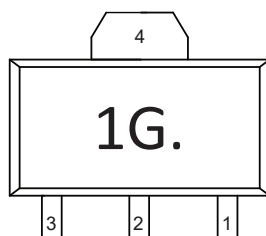
2.Part mounted on FR-4 board with recommended pad layout.

Internal Structure



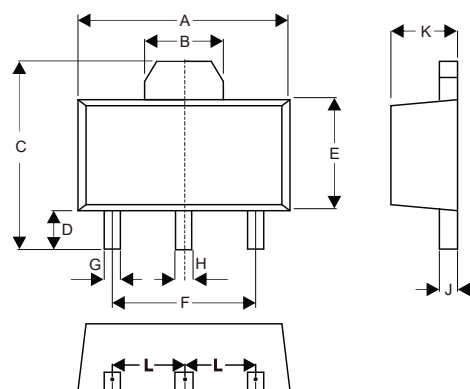
3.BASE

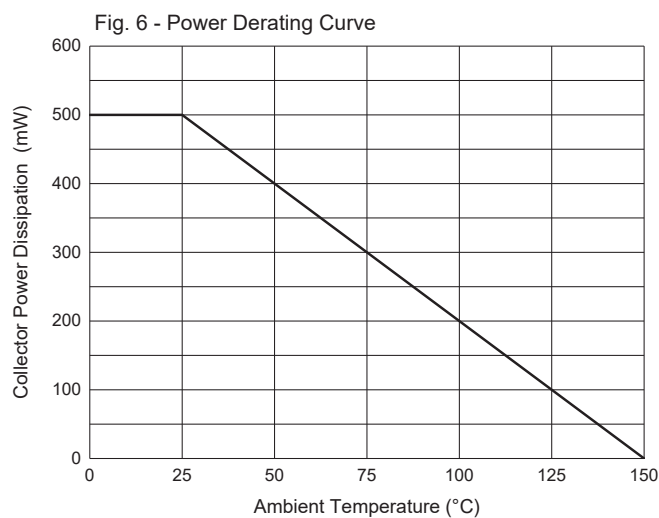
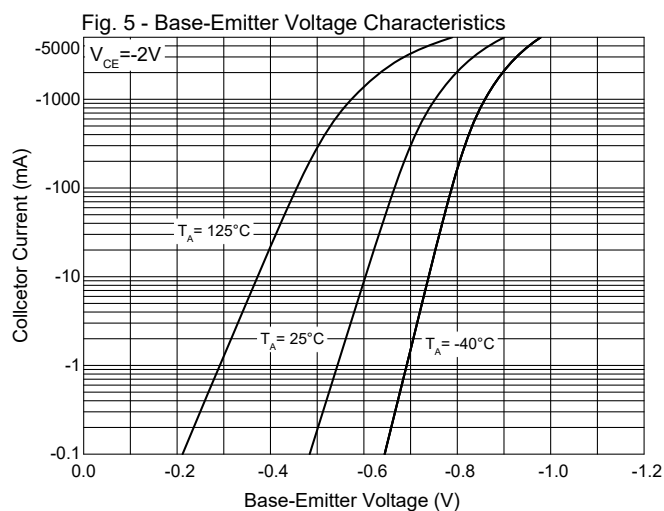
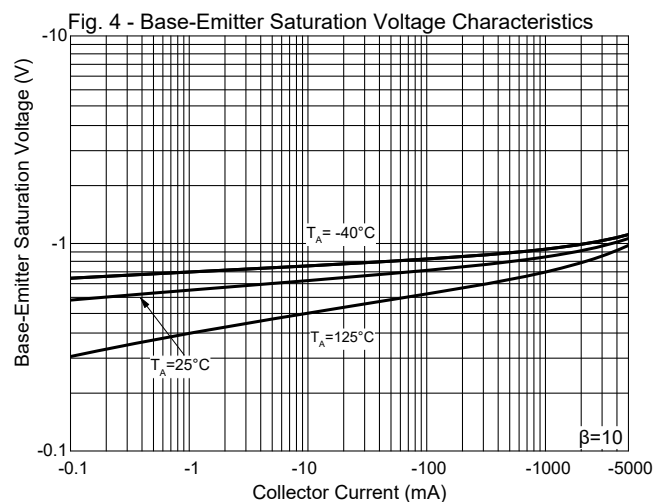
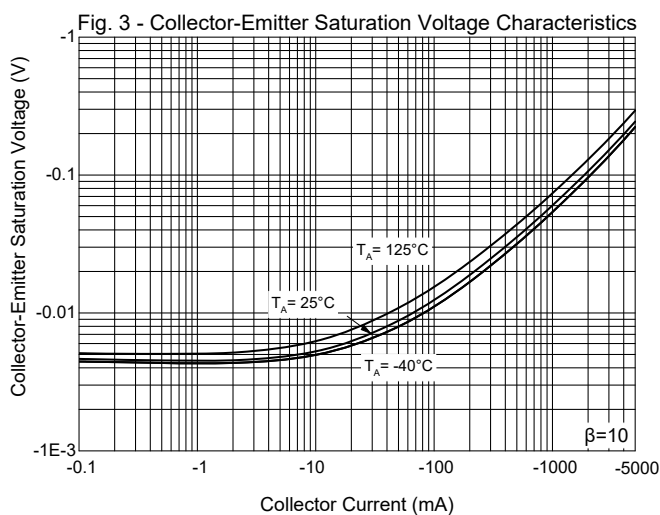
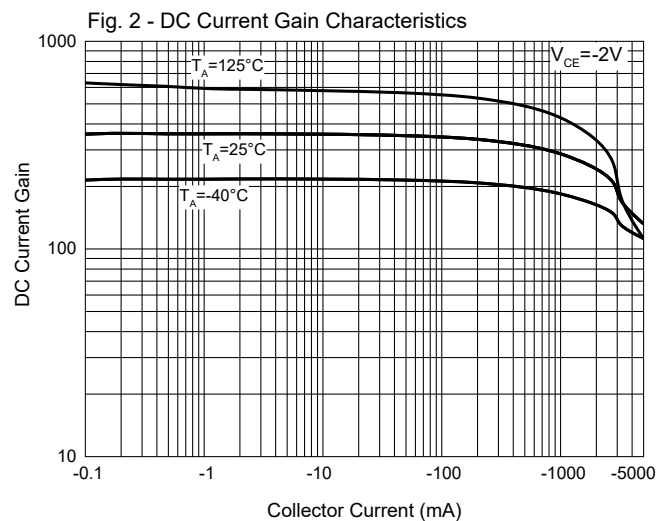
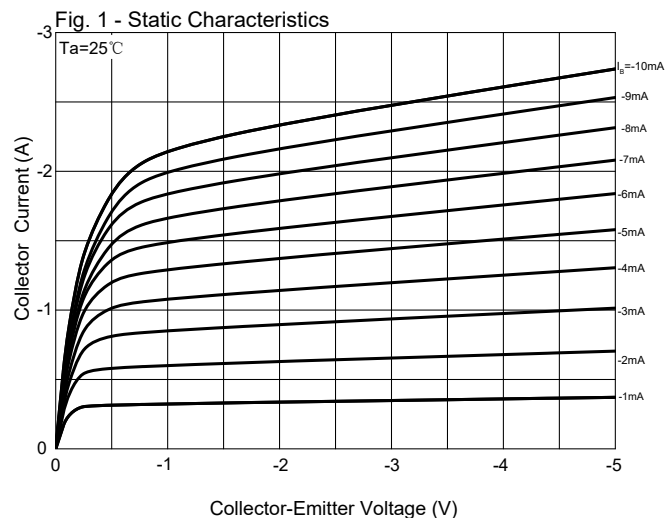
Suggested Solder Pad Layout
