


Fig. 1 - Typical Output Characteristics




Fig. 2 - Transfer Characteristics




Fig. 3 - $R_{DS(ON)}$ — V_{GS}




Fig. 4 - $R_{DS(ON)}$ — I_D




Fig. 5 - Capacitance Characteristics





Fig. 6 - Gate Charge

Fig. 7 - Normalized Threshold Voltage




Fig.8-Normalized On Resistance Characteristics




Fig.9 - I_S—V_{SD}




Fig. 10 - Drain Current





Fig.11-PD Dissipation

Fig. 12 - Safe Operation Area





Fig. 13 -Normalized Transient Thermal Impedance
