






Fig. 3 - Typical Forward Characteristics 10 T₁=25°C Forward Current (A) =75°C ₹ =125°C \(\sigma





Fig. 2 - Maximum Non-Repetitive Peak Forward Surge Current 120 100 Peak Forward Surge Current (A) 80 60 40 20 8.3 ms Single Half Sine-Wave 0 10 100
