






# 20 Amp Schottky Barrier Rectifier 20 to 100 Volts





Fig. 5 - Typical Instantaneous Forward Characteristics






Fig. 4 - Typical Instantaneous Forward Characteristics






Fig. 6 - Typical Reverse Leakage Characteristics



Percent of Rated Peak Reverse Voltage (%)


