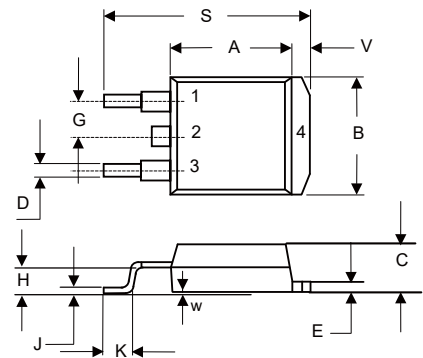

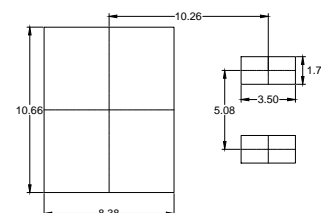

Fig. 1 - Typical Output Characteristics

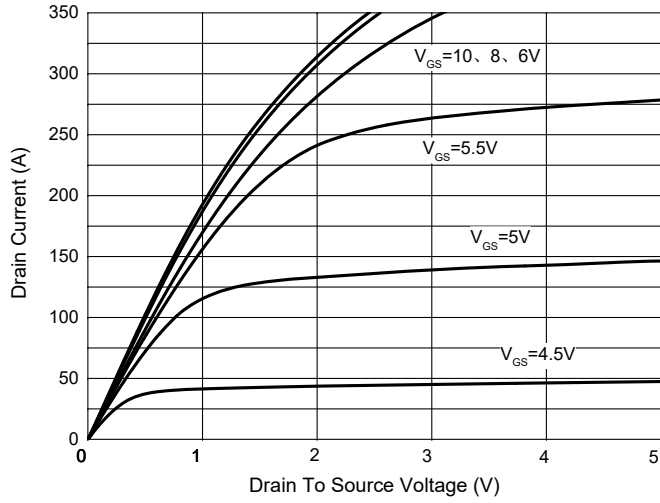


Fig. 2 - Transfer Characteristics

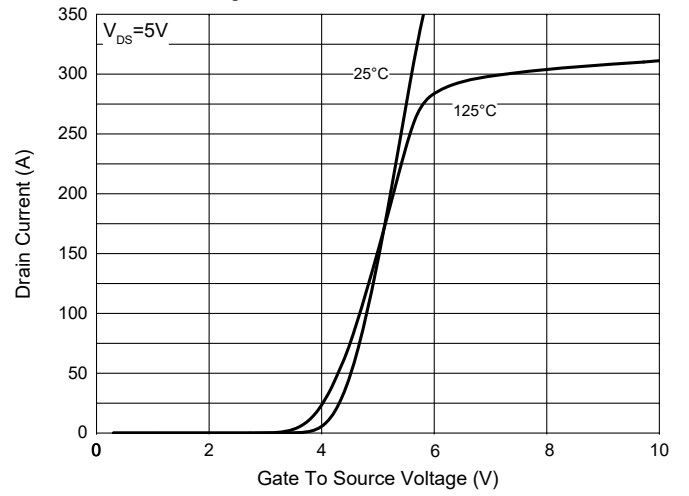


Fig. 3 -  $R_{DS(ON)} - V_{GS}$

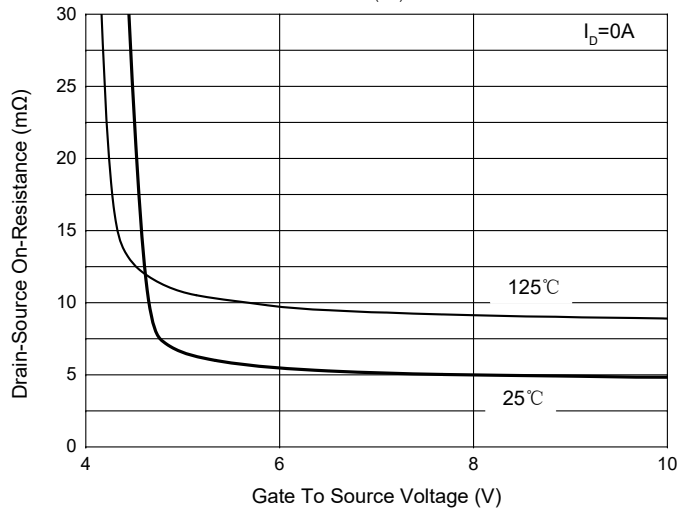


Fig. 4 -  $R_{DS(ON)} - I_D$

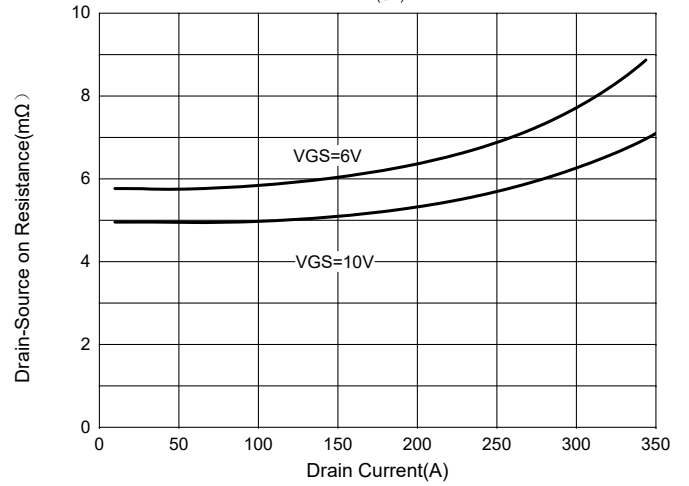


Fig. 5 - Capacitance Characteristics

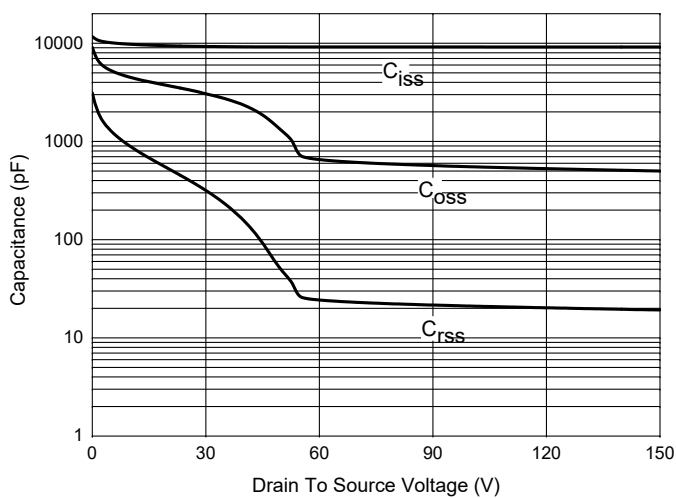
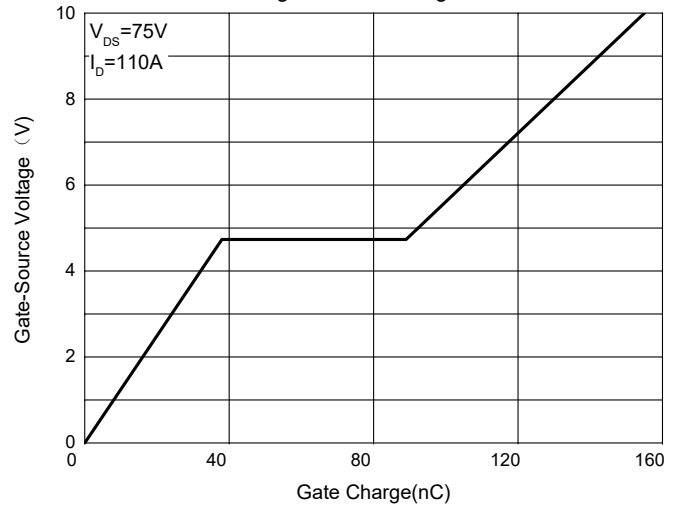


Fig. 6 - Gate Charge

Fig. 7 - Normalized Threshold Voltage

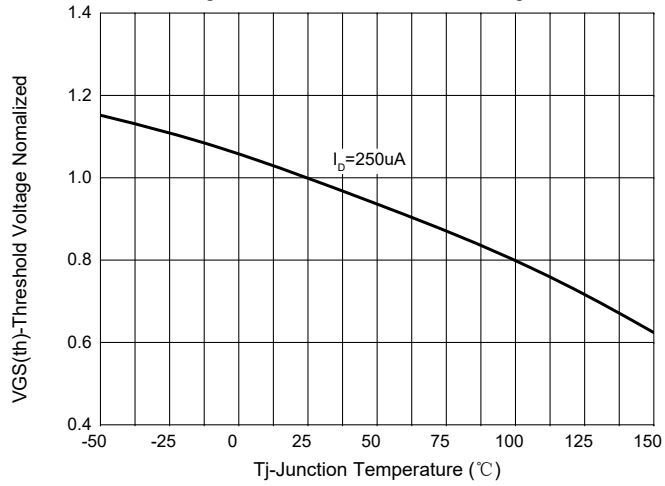


Fig.8-Normalized On Resistance Characteristics

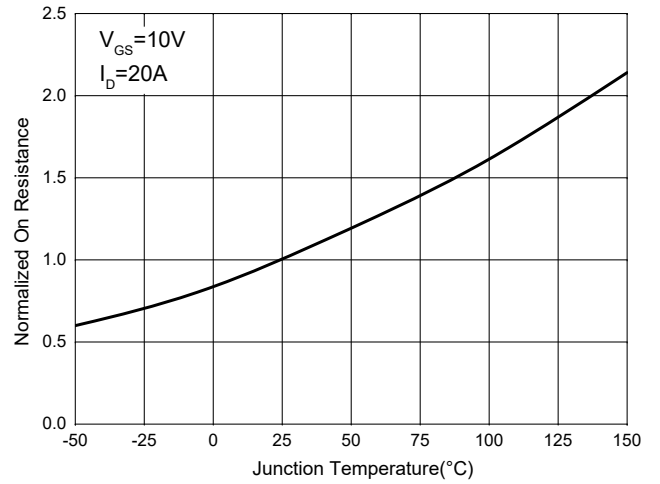


Fig.9 - I<sub>s</sub>—V<sub>SD</sub>

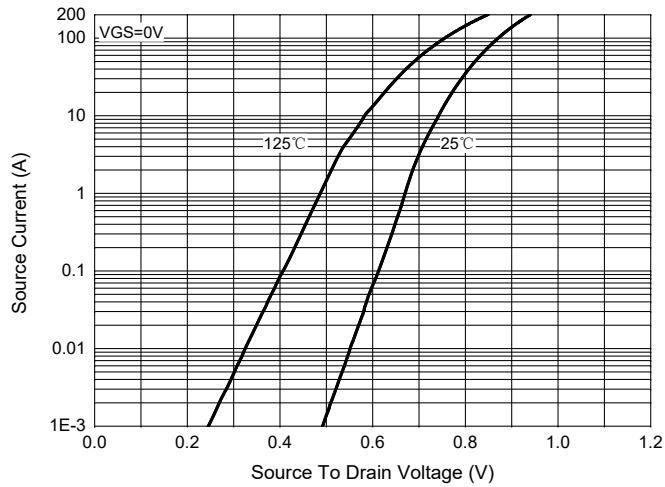


Fig. 10 - Drain Current

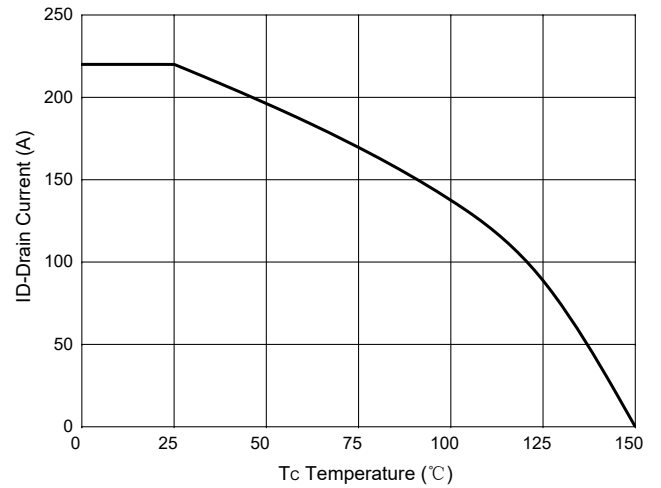
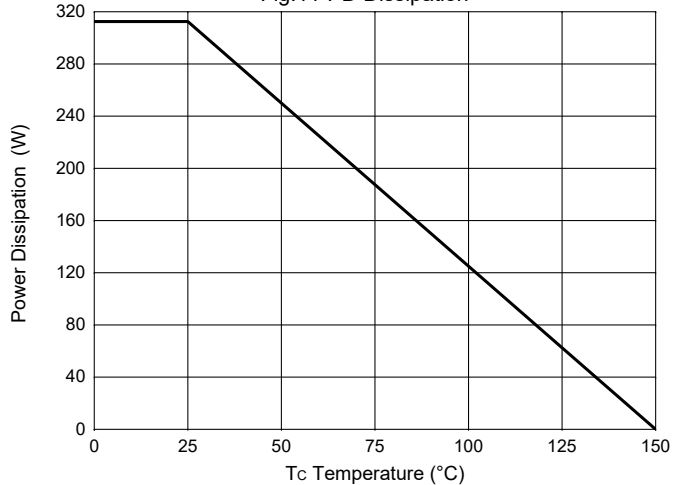


Fig.11-PD Dissipation

Fig. 12 - Safe Operation Area

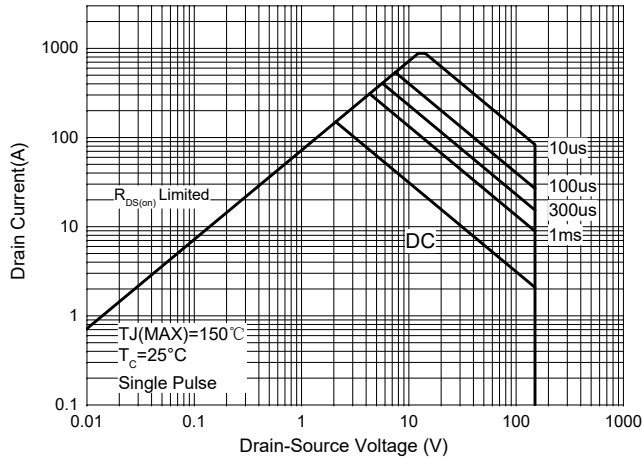
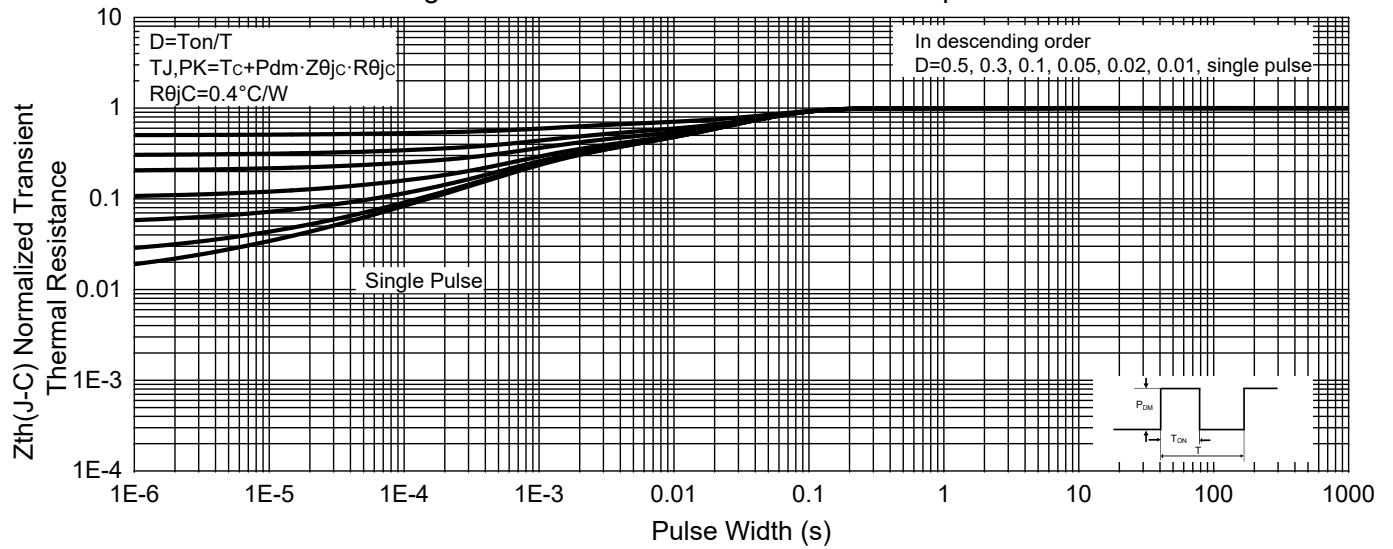


Fig. 13 - Normalized Transient Thermal Impedance
