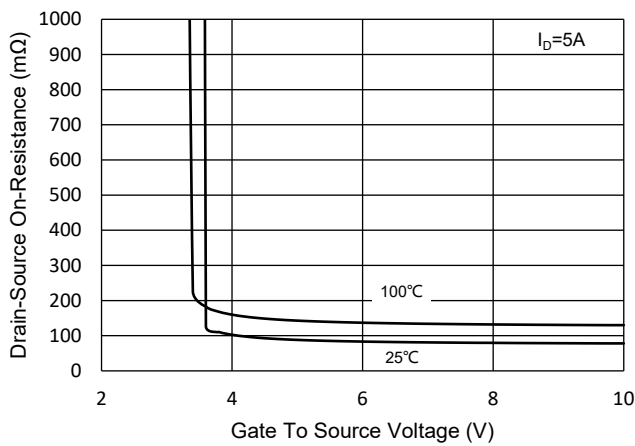
**Fig. 1 - Typical Output Characteristics**



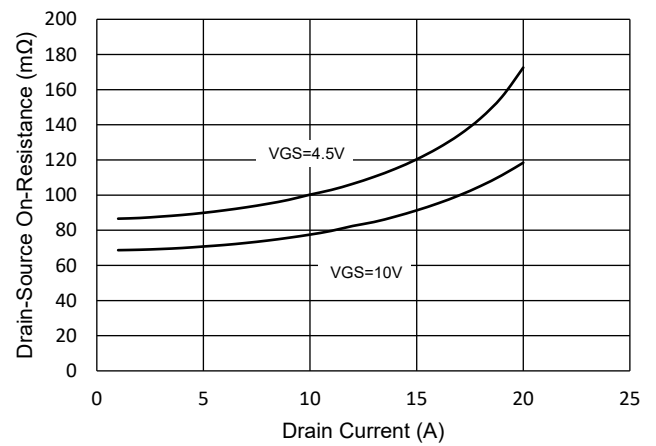
**Fig. 2 - Transfer Characteristics**



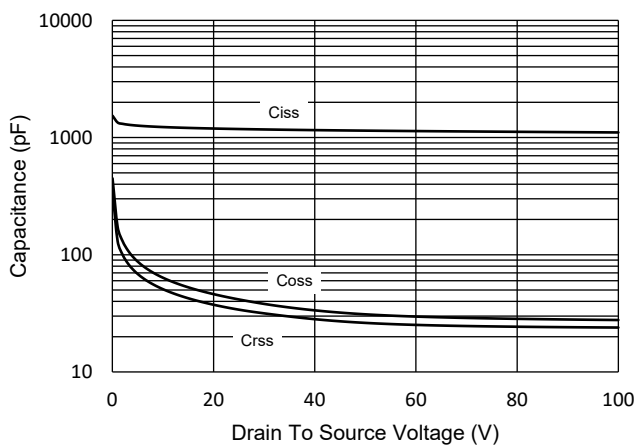
**Fig.3 -  $R_{DS(ON)}$  -  $V_{GS}$**



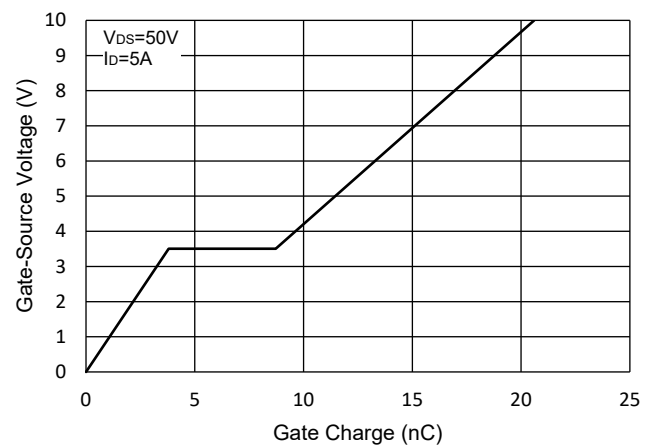
**Fig.4 -  $R_{DS(ON)}$  -  $I_D$**



**Fig.5 - Capacitance Characteristics**

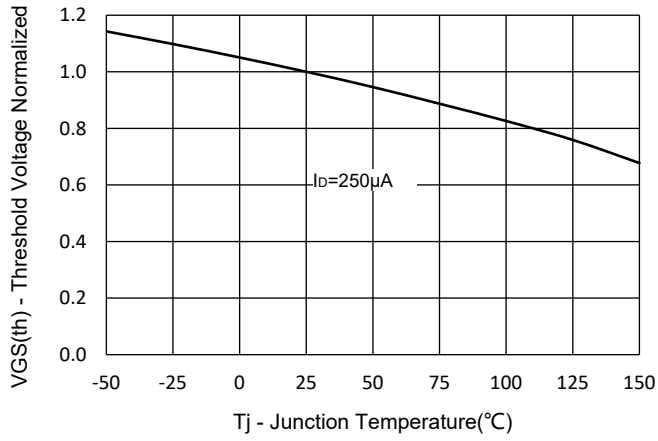


**Fig.6 - Gate Charge**

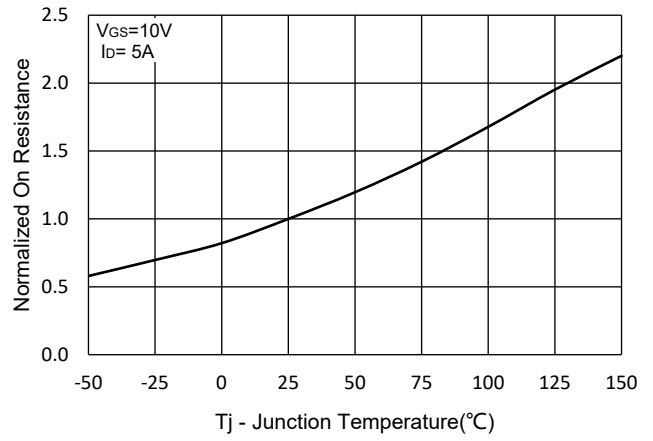

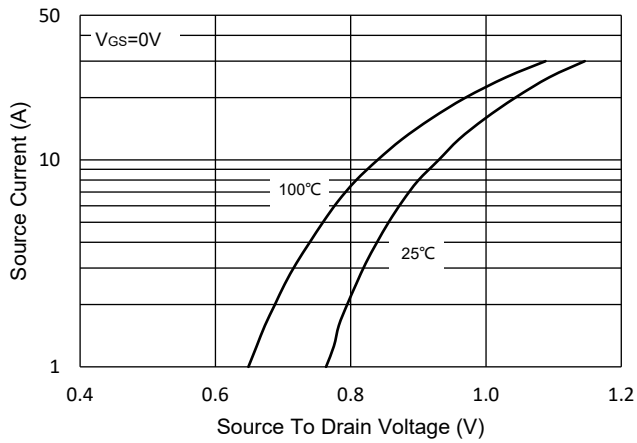
**Fig.7 - Normalized Threshold Voltage**



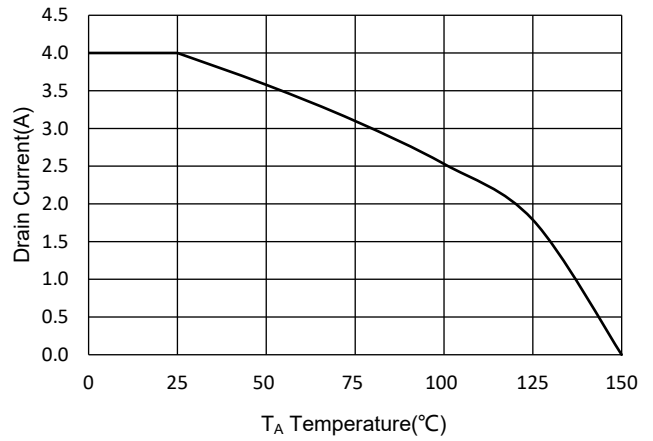
**Fig.8 - Normalized On Resistance Characteristics**



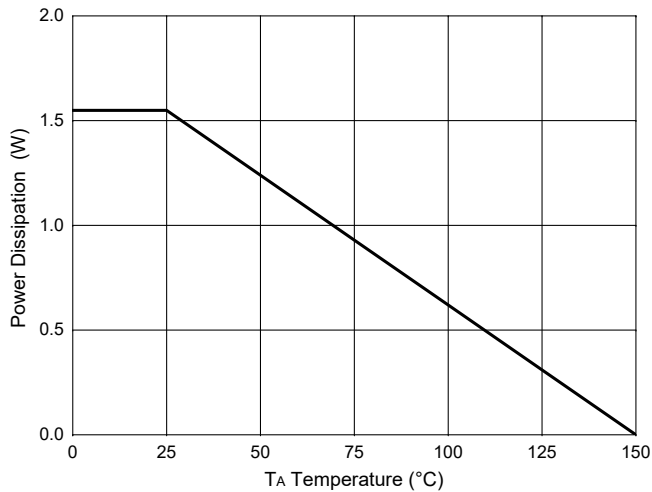
**Fig.9 -  $I_S - V_{SD}$**



**Fig.10 - Drain Current**

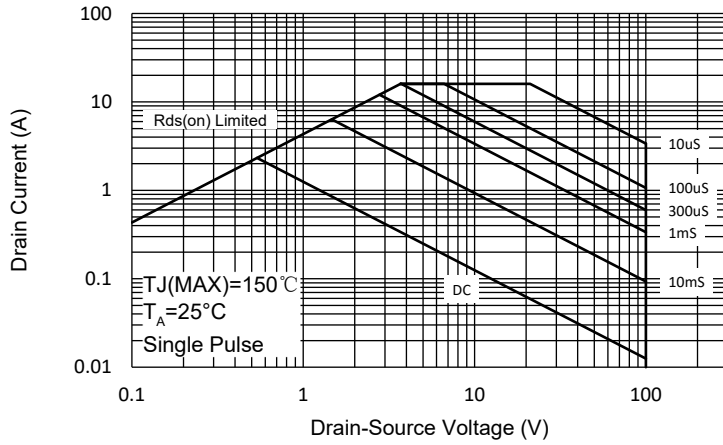


**Fig.11-PD Dissipation**

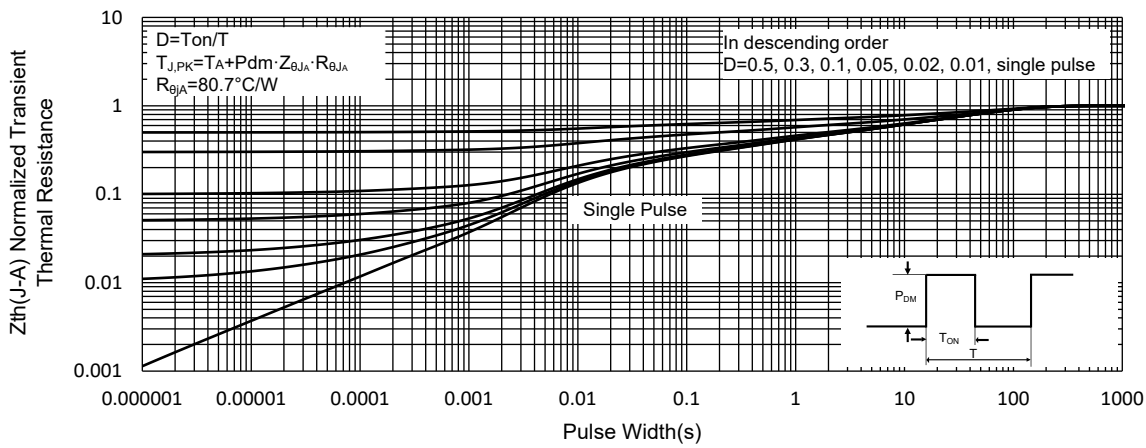
