







Fig. 2 - Maximum Non-Repetitive Peak Forward Surge . Current 35 30 Peak Forward Surge Current (A) 25 20 15 10 5 8.3 ms Single Half Sine-Wave 0 10 100 Number of Cycles at 60 Hz








Fig. 6 - Typical Reverse Leakage Characteristics
